You can update this number and still have it show up on the report as “Quoted/Q” up until the “Execution” in Yardi. At that point, and “con1” or “conc” will need to be added to the Move-In Calculator so it’s available when moving them into the system.

Some users have reported issues with the MFA login continually reporting Invalid Code. If this happens, please clear out your browsing history and try again, instructions are attached. Due to recent security enhancements, YardiOne will no longer provide the option to remember this device and MFA will be required with each login.

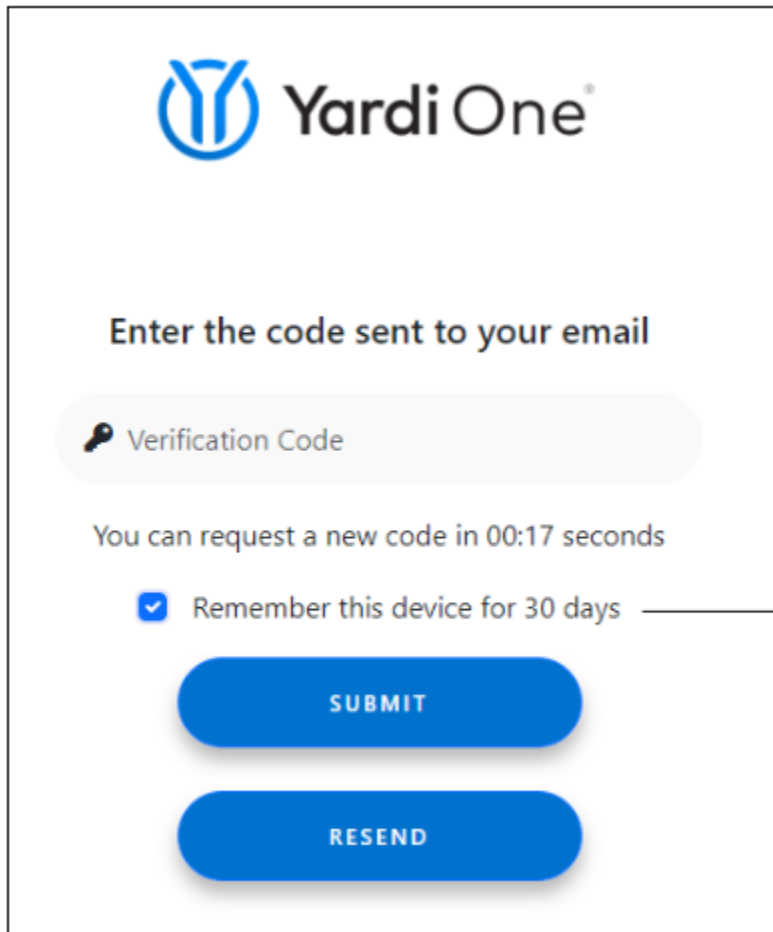

### 5. YARDI MULTI-FACTOR AUTHENTICAN (MFA)-attachment-2<sup>nd</sup> reminder

Now that we are up and running with YardiOne's MFA, we recommend having more than one MFA option setup in the event one is not working, such as email is down or no cell service is available.

The two most common are Text (SMS) and Email, with the third option requiring and Authenticator App to be downloaded to your phone.

In order to make changes to your YardiOne MFA, navigate to the YardiOne dashboard and click on your name and then My Profile. At the bottom of the screen is a tab labeled MFA Settings which will open a screen similar to what's displayed below.

In this example, the user has registered for email verification only. To add one of one of the others, click the Register button for the applicable method and follow the prompts. After
